NOTICE IS HEREBY GIVEN that the City of Woodinville will receive sealed bids in the office of the City Clerk at Woodinville City Hall, 17301 133rd Avenue NE, Woodinville, WA 98072 until **11:00 am, local time on January 23, 2018** at which time bids will be opened. Bids received later than **11:00 am, January 23, 2018** shall not be considered.

PROJECT DESCRIPTION: This Contract consists of a road diet project with a roundabout. Work also includes two culvert replacements, hot mix asphalt overlay, planing, signal improvements, illumination, drainage improvements, water main relocation, concrete curtain wall, interlocking sheet pile wall, cement concrete curb and gutter, cement concrete sidewalks, curb ramp replacement, traffic control, pavement markings, signing, landscaping, irrigation, and other work, all in accordance with the Contract Documents entitled: "**NE 171st Street Urban Parkway Project No. PW14-0208**".


